GUIDELINES TO SUBMITTING THE REBATE APPLICATION FORM

The Malaysian Association of Speech-Language and Hearing (MASH) is proud of its role in supporting the members' professional growth. Members of MASH can apply for a rebate to attend a seminar/talk/workshop/conference related to audiology or speech language pathology. This rebate is being offered as an incentive and reward for your continuous support to the Association.

It is important for you read the guidelines below in order to determine if you are eligible to apply for the rebate. Please complete the form on page 2 and return to the address below a **minimum of eight (8) weeks** prior to the seminar/talk/workshop/conference. Please allow a maximum response time of thirty (30) days following receipt of your completed forms.

1. All current MASH members with a minimum of 12 months of membership can apply for the sponsorship.
2. Each successful application is offered a rebate of RM250/= or 50% of the Conference Fee, whichever is lower.
3. The rebate will be awarded to a maximum of 4 Audiologists and 4 Speech-Language Pathologists in each financial year, this is subjected to the total amount allocated for the sponsorship fund in that year.
4. All current members who have fulfilled requirement No. 1, submitted completed forms, a copy of the event flyer and have met the deadline requirements will be fairly considered.
5. Your contribution to MASH in the past years will carry weight.
6. The final decision will be made by the Executive Committee and this cannot be disputed.
7. All successful rebate applicants will be notified via e-mail.
8. MASH will issue payment for rebate via cheque to the successful applicant after the certificate of participation and official receipt of the payment made by the applicant are submitted to MASH as a proof of attendance.
9. Following the event, a brief summary (with photos if possible) must be submitted to the Secretary, and may be published, as is, or in edited form, in Within Earshot to illustrate activities of MASH members.

10. In the event that the successful applicant, having paid in full for the seminar/talk/workshop/conference, and at the last minute, for whatsoever reason, does not attend the seminar/talk/workshop/conference, the Executive Committee has the right to retract the rebate.

NOTE: All members of the Executive Committee of MASH 2010-2012 are NOT allowed to apply for this rebate.
